

Tenant Application Steps

Thank you for your interest in our properties! At all GCC properties, rent is due on the first of the month. There is no grace period. If you are unable pay rent on the first, GCC Colorado will likely not be the best fit for your rental needs.

Here's how to apply:

- 1. Complete the attached GCC Colorado Tenant Application.
- 2. Please complete the application legibly, completely and accurately. Incomplete or illegible applications may be disqualified.
- 3. Complete the attached Electronic Funds Transfer form. You can use a checking account, credit card or debit card. If using a checking account, please make sure to attach a voided check (or copy).
- 4. Submit everything along with the \$30.00 application fee. You can mail it, email it or fax it to us.
- 5. If approved, we will automatically debit \$500.00 rent pre-payment from your account to hold the property for you.
- 6. Please visit our website at www.gccpartners.com for approval criteria. GCC Colorado believes in equal opportunity housing.
- 7. The rent pre-payment is NON-REFUNDABLE as we will remove the property from showing and make it "yours".
- 8. When the deposit is cleared by your bank, we will contact you within 24 hours to give you the good news and arrange the details of your move. The deposit secures the property for you for up to 30 days. The balance is due on by cashier's check or money order on move-in day.
- 9. If we are unable to approve you, we will not debit your account for any reason.
- 10. If we are unable to approve you for the home, we will mail a letter to your current address with the details. In these instances, we are unable to leave phone messages with the news in order to protect your rights under the Fair Credit Reporting Act.
- 11. Please allow up to five business days for the entire process.

Electronic Funds Transfer Authorization


I hereby authorize GCC Colorado to withdraw payments directly from my account on the 1st of every month during the entire length of my lease. Withdrawals will continue as scheduled should I move to a month to month lease agreement. GCC Colorado shall incur no liability if the balance in the account of the member is insufficient to cover the EFT or for any reason was not collectable. There is a \$25.00 service charge for each returned EFT. I understand that rent is considered late and unpaid if an EFT is returned for any reason. GCC Colorado is authorized to withdraw all accrued rent, late fees, rent increases and service charges. This authority is to remain in force and effect until lease expires or the termination is accepted by GCC Partners. I understand that it is my responsibility to notify GCC Colorado immediately in writing should I change my account or financial institution.

All transactions with your account shall be governed by the Electronic Fund Transfer Rules and Procedures and the Automated Clearing House (ACH) rules.
